ADMISSIONS PROCEDURE

1. Application—Return the completed application with the non-refundable application fee to the Admissions Office. Make checks payable to Rabbi Arthur Schneier Park East Day School.

Application Fee: \$50.00

2. School Records—School records are requested once an application is received. Letters of recommendation are welcomed but not required. For applicants attending school outside the United States, please have records (translated if necessary) sent directly to Rabbi Arthur Schneier Park East Day School Admissions Office.
3. Testing—Students entering Kindergarten through Grade 8 must take a test administered by the Educational Records Bureau, 220 East 42nd Street, Suite 100, New York, NY 10017, (212) 672-9800.
4. Interview and School Visit—Once an application is received, a visit will be arranged for each applicant as well as a family interview.

GENERAL INFORMATION

Medical Records: If your child is accepted to Park East Day School, the medical form must be completed and signed by a physician prior to the student beginning classes. Medical records must include all immunizations and comply with the New York State Public Health Law.

Financial Assistance: Scholarships are awarded on the basis of need. Assistance is available to students from Kindergarten through Grade 8. Families must fill out the Park East Day School Financial Aid Application each year and return it with the requested information. Financial Aid decisions are independent of the Admissions Committee decision.

Transportation: Students in Kindergarten through Grade 6 may receive school busing through the New York City Board of Education; eligibility requirements apply. Students in Kindergarten through Grade 8 may receive New York City Board of Education metrocards; eligibility requirements apply. Private busing is available to all students, subject to distance limitations.

TERMS AND CONDITIONS OF RABBI ARTHUR SCHNEIER PARK EAST DAY SCHOOL

This application is merely a request for admission. It becomes binding upon the undersigned only when the applicant has been examined, formally accepted, and a tuition fee is paid.

It is understood that places reserved in the School at the beginning of each year are taken for a whole year. No deduction from the year's fees can be made because of absence or for those who give up their place at any time during the year.

Rabbi Arthur Schneier Park East Day School reserves the right to exclude any pupil permanently or temporarily at any time, if the School deems such action advisable, either in the interest of the pupil or for the good of the School.

A parent's full obligation is outlined in the annual enrollment contract.
